CONGRATULATIONS TO THE 2014 WINNERS OF THE CNA EMPLOYER RECOGNITION AWARDS!

CNA is proud to honour employers who have demonstrated their commitment to excellent care through their support of the CNA Certification Program. At the CNA convention this past June in Winnipeg, the 2014 [Employer Recognition Award](#) was presented to Leisureworld Senior Care Corporation for its exemplary, sustained support of certification and CNA-certified RNs.

Leisureworld operates 35 long-term care homes in Ontario, 10 retirement communities in Ontario and British Columbia, and runs a program that provides services to seniors in their own homes. With considerable growth in the number of CNA-certified nurses in gerontology since 2010, the company offers RNs significant financial help, preparatory support and recognition with certification. For Leisureworld, certification is more than a one-time exam; it's a continuous process of ongoing support to enhance positive service and care outcomes. To date, 21 per cent of its 380 RNs have become CNA-certified.

Honourable mentions went to the University of Montreal Hospital Centre and Toronto Public Health. We also recognized our 2013 winner, the Princess Margaret Cancer Centre, since they had received their award in an off year for the CNA convention (which is held every two years.)

NEW RENEWAL REQUIREMENTS NOW IN EFFECT

Renewal for 2015 now requires 2,925 hours of experience in your nursing specialty/area of nursing practice over your five-year term, a decrease from 3,900 hours.

Other requirements have not changed. To renew, you must also do **one** of the following:

- Submit a record of 100 hours of continuous learning (CL) activities, earned during your five-year term, that are focused on your specialty nursing area.
- Write the exam.

Please take time to review the continuous learning activities [guidelines](#).

Inactive status is also available: If you are unable to meet the required renewal eligibility criteria (e.g., insufficient experience or CL hours), you may want to consider applying for inactive status. The cost is \$168 and it is valid for three years. Details and the application form can be found on the CNA certification [website](#).
